





Garfield County has 3 Active Drilling Rigs



Annual Well Starts, Garfield County



COGCC Rulemakings

- Governor's Oil and Gas Task Force Rulemaking Summary
 - Operator/local government consultation process prior to COGCC permitting process for large facilities near urban areas.
 - Operator registration with municipalities and Counties and multi-year development plan submittals
 - Hearings were Nov 16-17, Dec 7, and January 25.
 - Western Slope Governments Coalition: Garfield, Mesa, Moffat, Montezuma and Rio Blanco Counties *and* Parachute and Silt
- Noise Rulemaking (*Expected in 2016*)

Ursa Battlement Mesa Permit Applications

- County permit application was approved for 2 well pads within Battlement Mesa PUD
- COGCC permit review process is underway
- County and general public comments on COGCC permits due February 16th
- BOCC to discuss their comments to COGCC permits on February 8th
- Oil & Gas Liaison has standing agenda item for Battlement Mesa Service Association meetings to help ensure the County regularly engages the Battlement Mesa Community on oil and gas topics

BLM Draft Supplemental EIS on Roan Plateau

- BLM conducting supplemental EIS for leases on and near Roan Plateau
- Garfield County is a cooperating agency. Board of County Commissioners will draft their comments on February 16th
- Draft SEIS comments are due Feb 18, 2016
